## Toondah Harbour project to proceed to next stage

The Federal Government recently announced that the proposed Toondah Harbour Priority Development Area development is a "Controlled Action", allowing the project to proceed to the Environmental Impact Statement (EIS) phase.

This decision follows the unveiling of Walker Group's updated proposed masterplan for the project, which incorporates a number of new initiatives and feedback from leading environmental and wetland experts, the public and Federal Government. Walker Group lodged a new referral with the Federal Government to incorporate the new initiatives in early June 2018. The Federal Government's decision to declare the proposed project a "Controlled Action" is an important milestone. It is also an important step for the community and the beginning of a process that will include ongoing community engagement and consultation by Walker Group.

The EIS phase will take approximately 12 to 18 months and will address all potential social, economic and environmental impacts of the proposed development during its construction and operational phases. Environmental, construction and traffic impact management plans will be developed as part of this process.

### Responsible dog ownership

There continues to be problems on the island with people ignoring our local dog laws.

Anyone who is caught letting their dog off the leash in public faces a \$261 fine. Not everyone is comfortable when there are unrestrained dogs around and they can also be a safety hazard near roads.

Reports of dog attacks are treated with the highest priority. If your dog attacks or frightens people or other animals, your dog may be declared a menacing or dangerous dog, and you may also face prosecution.

Regular proactive patrols are also increased in response to complaints of dog owners ignoring the requirement to keep their pet on a leash at all times in public, unless in a designated off-leash area.

Residents who are concerned about straying dogs or those left to roam can report it to Council on 3829 8999. You can find full details of off-leash areas on Council's website at **www.redland.qld.gov.au** by searching for dog parks.



# Experts to look at coastal hazards

Redland City Council will hold a series of workshops with local experts and Council representatives in August to ensure it has identified areas affected by coastal erosion.

Straddie – particularly Amity Point and Point Lookout – is particularly susceptible to the impact of natural hazards.

In response, the State Department of Environment and Science has provided Council with \$490,000 to develop a Coastal Hazards Adaptation Strategy (CHAS) under the QCoast2100 Program.

This will identify areas most at risk, the level of risk and Council's response taking into account what the community wants done in each location.

The upcoming workshops will include one about Stradbroke Island and one focusing on the north Redlands mainland, including Cleveland and Raby Bay.



#### Catch up at a 'listening post'

I am happy that my townshipbased Councillor listening posts are continuing to be well received by residents, with senior Council operational staff very receptive to joining me when needed on visits to each township.

The next Straddie township meeting will be at 1pm on Saturday, 18 August at Dunwich Public Hall. This will be a chance to discuss issues and ideas important to the island.
